**Treasurer's Report** – For our main checking account the beginning balance as of March 1 was \$22,813.86. Deposits for the month totaled \$1,199.24 and that included meeting and membership fees, March sponsor, and raffle tickets. Our debits for the month totaled \$7,180.45 and that included conference social rental fee of \$3,634.53, conference social supplies, Executive Committee meeting lunch for \$538.85, March General meeting lunch for \$1,093.81, Conference Social split with SPRA for \$525.84, TV for Parks Day, scholarship money that was transferred to the Oak Lawn Park District for Delaney Harty for \$419. The ending balance as of March 31 was \$22,813.86. For the Wilson Family Fund savings account, as of February 1 the beginning/ending balance was \$16,832.65. For the Wilson Family Scholarship Fund savings account, we had a beginning balance of \$1,081.11. For the Wilson Family Scholarship Fund CD, there was no activity, so our beginning/ending balance was \$10,789.62.
